Pre-submittal meetings will be held virtually via Zoom on September 5, 2023, 1:00 to 2:00 PM Pacific Time; September 6, 2023, 9:00 to 10:00 AM Pacific Time, and September 7, 2023, 8:00 to 9:00 AM Pacific Time. A call-in number will also be provided. Meeting info will be provided upon registration.

9 Instructions for Submittal of SOQs

SOQs must be submitted electronically in PDF format by uploading to the Dropbox site accessed here: <u>https://www.cuwa.org/ta-program-rfq</u> by 5 pm, PST on September 29, 2023 5 pm, PST on October 13, 2023. Submittals after that date and time will not be considered. It is the respondent's responsibility to confirm that the submittal was uploaded on time.

Any SOQ received prior to the submittal deadline date may be withdrawn or modified by written request of the Respondent. To be considered, however, the modified SOQ must be received by the submittal deadline.

10 Selection Process

10.1 SOQ Evaluation Criteria and Selection as a Pre-Qualified Contractor

Submittals not submitted by the deadline in Section 9 and submittals not deemed complete based on the requirements in Section 7 shall not be considered. Of the eligible submittals, the following evaluation criteria and rating schedule will be used to determine the most highly qualified firm(s). Each submittal will be evaluated separately for each Service Category selected.

EVALUATION CRITERIA FOR EACH SERVICE CATEGORY	MAXIMUM % POINTS POSSIBLE
Firm's Qualifications	15%
Team and Team's Qualifications – this includes consideration of the breadth of experience under the Service Categories. It also includes consideration of the team's experience and abilities related to engagement with DACs and non-English speaking communities.	35%
Project Experience and References	40%
Small/Local/Disadvantaged Business	10%
TOTAL SCORE	100%

Selection as a Pre-Qualified Contractor for Service Categories requires a score of at least 65%.
